AFRC Chairman Dr Kelvin Wong's Speech on AFRC Launch Ceremony

Good evening the Honorable Paul Chan, Financial Secretary, distinguished guests, fellow board members, colleagues, ladies, and gentlemen,

Second, as a promoter of governance, we need to shape a competitive environment that will create long-term impact and to provide guidance to regulatees and stakeholders as a thought leader to drive influence and impact. Third, we will leverage on the power of Dialogue, Understanding and Collaboration to identify and address the expectations of the public, the challenges of the profession, and the requirements of other stakeholders.

As we will soon regulate small to medium size practitioners, we are fully aware of the challenges they face. According to the recent annual survey conducted by International Federations of Accountants (IFAC), the critical challenges are the attraction of new clients, keep up with new regulations and standards, pressure on lower audit fees, rising costs, technology development, staff retention, and succession plan.

Despite all these challenges, I have undoubted faith and confidence in our future. HK is a vibrant IFC and business hub. I don't think there is a better place to focus on collaboration than Hong Kong, which is more than a city. It is a spirit of constant adaptation to whatever challenges and difficulties we might have faced. It is a spirit of doing things better and smarter, a city with strong ethics and business integrity. Together we create more opportunities by shaping values and standards to create meaning, trust, hope, optimism, and hence results, not only for ourselves today, but for our young generations tomorrow.

The FRC wouldn't have been able to discharge its duties without the supports of our key stakeholders. On behalf of our board, I want to convey the following thanks to all of you and I look forward to your continual supports to ensure the AFRC can better promote a healthy development of the accounting professions through our regulations. Our grateful thanks to the HKSAR Government for their vision, trust, confidence, and staunch support to the FRC for our first reform in 2019 to become the independent regulator of PIE auditors; and the further reform in 2022 to further expand our remit to the accounting profession.

Our heartfelt thanks to our former chairpersons, former and current members of the Board, Committees, Honorary Advisory Panel, Process Review Panel, and Financial Report Review Panel for their guidance and contributions toward building a firm foundation for the FRC.

Our sincere thanks to the community of Financial Regulators in Hong Kong and the Mainland, for their collaboration and co-operation in matters of high public interest. Our joint effort not only results in better investor protection but further strengthens public trust to our markets.

Our warm thanks to the HKICPA for working with us seamlessly to ensure a smooth transition of the Further Reform. And we look forward to working even closer between us in future.

Our particular thanks to the PIE auditors who have been supportive to our functions since 2019.

My special thanks to our Management and staffs. Your wholehearted dedication to our mission and gritty performance amidst the Further Reform have demonstrated your staunchest passion and commitment to the AFRC!
