# AFRC announces appointment of new Honorary Advisers

Prior to her retirement in January 2025, she held dual leadership roles as General Manager, Group People & Culture Services for Jardine Matheson, and People & Culture Director of Jardine Pacific. Throughout her career, Ms Leung spearheaded initiatives in HR and talent strategy, leadership development, cultural transformation, and executive compensation and reward.

Mr Peter Kan's career in audit and financial services spans across the UK, Hong Kong and Mainland China, where he served as an audit partner in the Beijing office of KPMG China. With extensive experience in delivering audit services to both PRC and international companies, Mr Kan brings a wealth of expertise in cross-border financial practices. He retired in June 2014 after a career spanning more than 25 years.

Dr David Sun, Chairman of the AFRC, remarked, "We are honoured to welcome Sir David Tweedie and our new Honorary Advisers.
